To his Excelency William Shirley Esq. $^{\rm r}$ the Hon. $^{\rm ble}$ his Majestys Council and house of Representatives in general Court Assembled \sim The Memorial of Pain Mayhew, John Sumner and William Hunt humbly Sheweth \sim that --

Whereas being served with the Coppys of Two Petitions by way of Complaint from the Indians of Gayhead, to which we make Answer: that we as Guardians to the Indians in Duke's County pursuant to the Power and Trust Reposed in us Aby an Act of the general Court Met and Sett off to the Indians belonging to s.d Gayhead (being in number about hone hundred & twelve Ninety Two men, women and Children &) about Thirteen hundred Acres of Land, and then sett up Publick Notifications thro'out the s.d County that (on a Certain Day in them prefixt) the Remainder of s.d Neck of Land belonging to the Indians was to be Lett to such Person as would Give most for the same p. year during the Term of six years from and after the twentieth day of October then next ensuing: Reserving to the s.d Indians the English-built Houses thereon, One Acre of Land adjoyning each House, and the priviedge of taking off all the fencingstuff of Posts, Rails and Stakes thereon, also liberty for the s.d Indians to Ago a Cross s.d Land a Fishing, and the Tenant or Tenants to maintain all the Fences between the Leased Premises and that Reserved for the s.d Indians. As to the Article of pulling down the Indians Fence we Suppose it is true that the Tenants did so, for being bounded by the place where the Indian fence stood the could not put up their own fence without pulling up the other upon which it is [illegible]d_[hole]s to observe to hold vour hon.ble Court it is so obvious, that this was entirely for the Indians benefit, they having their own Fence to Improve for their own use elsewhere. We Leased s.d Land for Four hundred and Sixty five Pounds Old Tenor p. Annum the One half thereof to be paid at the End of every Six Months. as to their Indian built houses to be taken off s.d Land, it is no more than what they commonly practice themselves. As to their Fire-wood ther is enough for their use on that part of s.d Neck which is sett off to them which is as good wood as is generally growing on any part of s.d Neck of Land; and the wood that is growing on the Leased Land is very Small, Scarcely a Stick large enough for a hedge Stake. as to the Article of Complaint viz: our turning off their Catle and not Reserving Feed enough for them it is utterly false, for there is a great deal more Grafs growing on the Land sett off to the s.d Indians than their Catle can Eat before the Winter will Aordinarily spoil the grafs, as will appear by the Evidence herewith Exhibited. and as to the Objection made against the Persons to whom the Lease was made we answer it being Sett up at a Publick Vendue every person present had a Right to bid for it; and they themselves had but a litle time before Let the priviledge of Feeding the whole Neck to several of the same persons as appears by a writeing and the hands of their Com. tee herewith presented, and we doubt not but that the hon. ble Court will Dismfs s.d Petition as groundlefs and vexatious as we humbly apprehend they realy are, we having acted in the s.d affairs with integrity, and with no other view than to Serve their Interest, and that we have used the likeliest methods therefor we doubt not but that we could procure the Testimony of every unprejudiced Judicous person in the County and your memorialifts as in duty bound shall ever pray &c.
