of it I have this Day Sold to Elnathan Gridley which Third part
Contains by Estimation Ten Acres But be the Same more or Less
as it Lyeth undivided with the other Two thirds Now Sold to Elijah
Weampy together with one third of my dwelling House and and
Barn Standing on Said Land the whole of Said Piece of Land as it Lyeth
undivided is Butted and Bounded West on Land this Day Sold to Elnathan
Gridley East on Highway North on the River South on Several Lotts of
Land Lately Laid out to Several persons ------

To Have and to hold the above Granted and Bargained Premiffes, with the Appurtenances thereof, unto *him* the faid *Cornelius Indian his* – Heirs and Affigns forever, to *his* and their own proper Ufe and Behoof.

And ALSO, *I* the faid *Solomon Hart* – Do for *my* felfe *my* Heirs, Executors and Administrators, Covenant with the faid *Cornelius*

Heirs and Affigns, That at and until the Enfealing thefe Prefents, *I am* well Seifed of the Premiffes, as a good indefeafible Eftate in Fee Simple; and have good Right to Bargain and Sell the fame in Manner and Form as is above Written; and that the fame is free of all Incumbrances whatfoever. And FURTHERMORE, *I* the faid *Solomon Hart*

do by these presents, bind *my* selfe and *my* Heirs for ever, to Warrant and Defend the above Granted and Bargained premises to *him* the said *Cornelius*

Indian his Heirs and Affigns, against all Claims and Demands whatsoever. In WITNESS WHEREOF, I have hereunto set my Hand and Seal the 21^{st} Day of March In the 3^d Year of the Reign of Our Sovereign Lord George the 3^d of GREAT BRITAIN, &c. KING, Anno Domini, 1763
